



RULES FOR ACCOMMODATION IN THE CANARY ISLANDS OBSERVATORIES

According to the regulations decreed by the relevant Spanish administrative authorities that you can see in the annex at the end of this document.

1.-NATIONAL AND REGIONAL REGULATIONS

Application cases:

1. In order to be able to stay in the OOCCs, non-residents and residents of the Autonomous Community of the Canary Islands must, on entering the territory of the Autonomous Community of the Canary Islands, provide proof of compliance with one of the following health certificates:
 - (a) Diagnostic test for active infection by COVID-19 with negative result carried out no more than 72 hours prior to arrival in the Canary Islands. (PCR, TMA or antigens) (Diagnostic certificate).
 - b) Have an official document accrediting that they have received the complete vaccination schedule within the 8 months prior to travel, or at least one dose of a vaccine authorised by the European Medicines Agency (EMA) against COVID-19 - in this second case more than 15 days prior to travel - within the four months prior to travel. (Certificate of vaccination)
 - c) Prove by means of an official medical certificate or public document that they have had the disease for less than 6 months (Certificate of recovery).

2. Exceptions to the conditions of access referred to in the previous section:

- a) Persons who accredit the status of resident in the Canary Islands and declare under their responsibility that they have not left their territory in the 15 days prior to their arrival at the establishment, and that furthermore in said period they have not had symptoms compatible with COVID-19.
- b) Persons, regardless of their place of residence, who can prove that they have been outside the Autonomous Community of the Canary Islands for a period of less than 72 hours prior to arrival, having remained in its territory during the 15 days prior to the aforementioned period of absence of less than 72 hours, and who also declare under their responsibility that during this period they have not had symptoms compatible with COVID-19.

When booking accommodation, users must sign a declaration (ANEXO IV BIS) stating one of the three conditions of access listed in the previous section that apply to them. Once this document has been received, the reservation will be confirmed.

The IAC will refuse accommodation at the Canary Observatories to anyone who does not meet with the aforementioned conditions to its case. If you find yourself in this

situation, it is recommended that you call Reception to find out where you can be accommodated nearby (at your own expense).

All users must provide proof that PDIA has been performed within the period indicated by producing a certificate, either telematic or on paper, which states the date and time the test was carried out, the identity of the individual tested, the laboratory responsible for its verification and nature, and the negative result.

The vaccination certificate shall include at least the following information name and surname of the holder, date of vaccination (indicating the date of the last dose administered), type of vaccine administered, number of doses administered/full course, issuing country and identification of the body issuing the vaccination certificate. And the recovery certificate shall include at least the following information: name and surname of the holder, date of sampling of the first positive diagnostic test for SARS-CoV-2, type of diagnostic test for active infection performed and issuing country.

Before arriving at the Canarian Observatories, users must download and keep active during their stay, as well as for 15 days immediately after their departure, the Radar Covid mobile infection alert application (point 11 of Decree-Law 17/2020).

2.- ORM RESIDENCIA USER RULES COVID-19 (10/05/2020)

- To protect the health of users and employees in the Residencia, the necessary collective protection measures have been taken to ensure compliance with the established rules. Appropriate protections have been installed in the points of interaction of people inside the building: protective screen at the Reception desk, at the Administration office and catering service.
- All service personnel outside these protected areas must use the appropriate protective masks and must keep a distance of 1,5 meters from the other staff and users.
- Users accessing the Residencia must comply with the same recommendations regarding the use of masks and respect the 1,5 meters distance. Use of the mask along the entire area. Some cleaning points with hydroalcoholic gel have been set up in the Residencia: One at the Reception area, one at the entrance of the dining room and another one at the first aid room.
- The common areas in Annex VI can be used with the limited capacity indicated on the signals.
- The kitchen-dining room service may be operative, as long as the food is distributed in packages with specific technical health guarantees (packaging, plasticizing, etc.) These foods may be taken in the dining room, keeping a safe distance of 1,5 metres. The dining room has a limited capacity of 14 people. Due to capacity limitations, please respect the shifts assigned by the reception and avoid spending more time than necessary in the common areas.
- The use of rooms will be strictly controlled in terms of their cleanliness, and they will not be allowed to be used until 24 hours after their last use. To carry out the cleaning of the rooms during the stays of more than 7 nights, the user will be informed during check-in of the scheduled cleaning days, so that the user can leave their belongings collected and be informed of the timetable, thus avoiding the user and the cleaning staff coinciding in the room during the service.

- The rooms will be for individual use. Double use is not allowed.
- The Residencia has a temperature thermometer, recommending its use for users who enter the building.
- As for the rest of the common areas, continuous cleaning measures have been taken during the hours when the building is most crowded.
